I. TITLE OF COURSE: NR1705- Role Development of the Practical Nurse

## II. COURSE DESCRIPTION: 5 credit hours 3 credit hours of lecture and 2 credit hours of lab per week.

Five (5) credit hours. A three (3) credit hour theory/lecture and two (2) credit hour clinical course focusing on understanding the role of the practical nurse as a manager and provider of care under direct supervision. The practical nurses function as a member within the discipline of nursing is emphasized. Curriculum threads of pharmacology, communication, client teaching, and critical thinking are utilized while providing care for a group of patients in an

acute or long term care health care facility. Utilizing the nursing process, the student identifies human responses to actual or potential health problems to determine appropriate nursing care. The clinical experience utilizes eight hour shifts to enhance the student's educational experience.

For each unit of credit, a minimum of three hours per week with one of the hours for class and two hours for studying/preparation outside of class is expected.

Pre-requisite: Successful completion of all other courses within the practical nursing curriculum.
