### I. TITLE OF COURSE: NR2503- Mental Health Nursing

#### II. COURSE DESCRIPTION: 3 credit hours 2 credit hours of lecture and 1 credit hours of lab per week.

Three (3) credit hours. A two (2) credit hour theory and one (1) credit hour clinical course. The nursing process serves as a framework for studying behavior along a continuum, ranging from mental health to mental illness. The role of the A.D.N. is enhanced as both a provider and manager of care as the student learns to recognize actual and potential behavior patterns and the human responses in adults, children (pediatrics), and families. Clinical experience will provide an opportunity to increase skills and knowledge of communication, psychotherapeutic medications, and client teaching, and function as a member within the discipline of nursing. The student will apply the nursing process and utilize critical thinking in providing and managing care for clients and families in the community.

For each unit of credit, a minimum of three hours per week with one of the hours for class and two hours for studying/preparation outside of class is expected.

Pre-requisite: Admission to the Nursing Program & successful completion of Level 1 of the Nursing Program or the LPN/ADN course.
